January 2020 – Proposed Footpath Diversion

Dear Resident,

Following November 2019 newsletter circulated to you, we wish to confirm the pending temporary closure of your current access through Arthur Wade and Robert Owen House for approx. 10 weeks, commencing April 2020. This is to allow the safe completion of the external works for the new building on Baroness Road.

As previously notified the primary reason for this closure is to ensure safe separation between pedestrians and machinery whilst we construct the new footpaths and road ways as part of the Baroness scheme, these works will also include the landscaping and planting works.

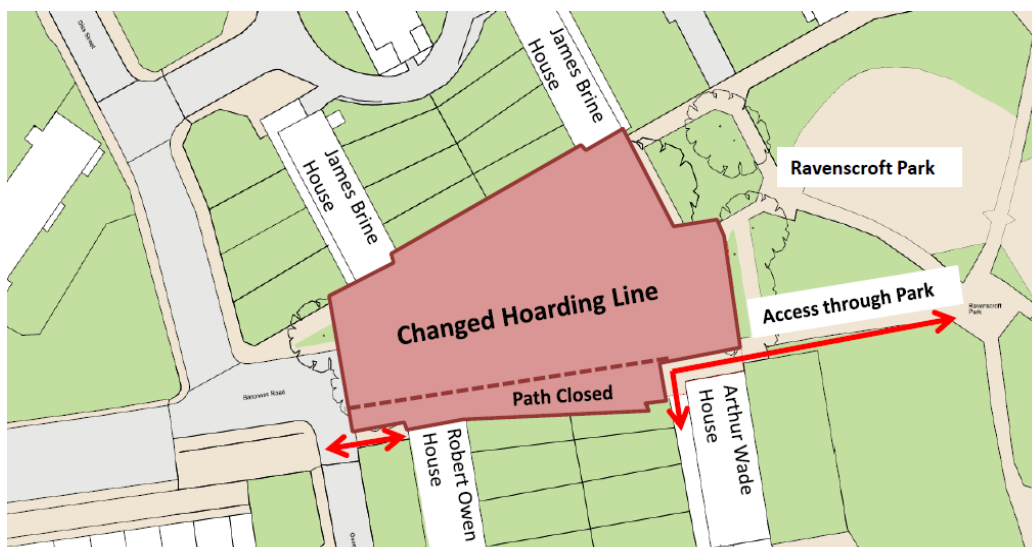
During this period, access will be provided as per the attached diagram below, through the current park at the back of Arthur Wade House.

We wish to apologise for any inconvenience this may cause and will keep any disruption to a minimum.

There should be no noisy works before 8am.

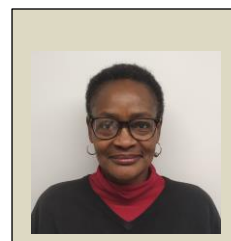
